# 1&2. Welcome, Call to Order, Greeting, Agenda Overview:

Michele Hannagan called the meeting to order at 5:36 pm. A quorum was present at the beginning of the meeting.

#### 3. Review & Approve Minutes:

#### 4. Finance:

- A. Reviewed the FC-YTD Financial Report for the months July through January, 2023
  - a. Enrollment is still below full capacity and it is unlikely that we will be able to reach full enrollment.
  - b. Food Services we have received all the money due.
  - c. CSP we have received 20% and more is on the way.
  - d. All other lines are in line with expectations
- B. Retirement Funds we have our NYSTR number and teachers are all set. We don't have the state number for the support staff (Michelle) but it should be in place very soon

# 5. Leadership Update - Christine Farrell

- A. Recruitment We now have 166 applications for the 2023-24 school year. This is not a large pool. We need to come up with a strategy for attracting families. One issue is that we don't have a budget for advertising. The Parent Association is actively recruiting and has asked to have a booth on Goodman St. (at the foot of the driveway to the school) during the Lilac Festival.
- B. Attendance
  - a. We currently have 82 students, and a new student will start after the Spring Break bringing the total to 83.
  - b. Attendance is at 90% some of this is the illness from post-pandemic susceptibilities that all schools have.
  - c. Tardiness by students is being addressed. Some have semi-legitimate reasons, others not so much.
- C. Expeditions Christine shared the book that was created by the First Grade for their Exhibition Night. (Note: Attendance at the Exhibition Night is OK but needs work. Asking teachers to stay at night for school functions. Teachers are asked to be here 9 nights per year.)
- D. Discipline (Note: not all incidents are being reported, so the following numbers only reflect the discipline forms that are being filled out and completed).
  - a. 81 incident reports involving only 15 students. 38% reported as minor incidents, 55% were reported as Major Incidents. 7% were not noted as Major or Minor.
    - i. Most common Minor infraction: Not keeping hands to themselves
    - ii. Most common Major infraction: Intentional physical harm
  - b. Christine shared the letter that was sent to families about our rules. Many student report that their parents have told them it is OK to hit other kids.
  - c. 1 Student was suspended for 1 day.
  - d. 1 Student received in-school suspension for 1 day (a tutor was hired to ensure that the student was actively and productively engaged in lessons during the day).
  - e. Discipline will be addressed during a coming staff development day.
  - f. Many students in grades K-2 have special needs but do not have IEPs yet. Christine stated that she is treating them as if they have an IEP which allows some modification of school rules and expectations to meet specific needs.
