Executive Director Evaluation Follow-Up - *Michele Hannagan & Kevin Sutherland*As a follow up to discussion at the last meeting, market comps were reviewed for charter school Executive Director role and the Finance Committee (Kevin) was tasked to make a recommendation for compensating Shannon accordingly. Four other charter schools in Rochester with different numbers of students were used as comps to better understand the compensation of Executive Director roles in this area which averaged out to \$345 per student. The recommendations were based on GCCS's number of students and projected growth over the next 4 years.
