### Overview of charter renewal:

Section highlights:

- Performance benchmarks derived from NYS testing, looking at proficiency as well as movement toward proficiency. Narrative section can include iReady data to make up for missing data from students who opted out.
- 2. Organizational capacity: Lisa Wing to be involved in drafting this section.
- Mission (critical thinkers, reflective questioners, problem solvers, articulate communicators)
- 4. Recruitment, Enrollment, & Retention—highlighting outreach efforts, and very strong retention statistics.
- 5. Charter revisions: No material changes planned. School leader will inquire with Susan Gibbons whether a formal revision is required to add a succinct vision statement that is easier to recite than the (lengthy) mission statement.

The board engaged in lengthy discussion about Benchmark 9 (Recruitment, enrollment, and retention): Revising charter language around enrollment demographics would necessitate changing the mission statement due to implications for diversity. School leader anticipates that enrollment and lottery data as well as new recruitment efforts (including plan to join E3) should support the "good faith" narrative. We can also highlight how the curriculum builds capacity in *all* kids to be culturally responsive.

The charter renewal document will be uploaded for board review by Monday July 22<sup>nd</sup>, followed by meeting August 7<sup>th</sup> for board vote to approve. Counsel will review rules for phone-in attendance for the meeting.

## School year calendar
